## Terms and Conditions For Sellers and Buyers

- The Greater Quad City Auto Auction is acting as an agent only and does not have any ownership interest or liabilities in regards to the events held on June 9, 2007 deemed The MIDWEST CLASSIC.
- All Vehicles will be sold "AS IS", "WHERE IS".
- As the Seller, you represent and warrant to GQCAA and the buyer that you are the lawful owner of such item and ensure that such item is free and clear of all liens and encumbrances.
- You also represent and warrant to GQCAA and the buyer that you have good right to sell the same and that good and marketable title to such unit will, at such time the unit is listed, be conveyed to such buyer free and clear of all liens including without limitation any tax liens, encumbrances and adverse claims.
- Reserve Sales Commission will be 4% of sales price.
- The Seller is responsible for producing a negotiable title and for the representation of the vehicle offered at auction.
- The seller reserves the right to refuse or accept the last bid if the vehicle is under the protect price. The buyer and seller must pay all fees if any subsequent sale results.
- All guarantees and announcements are between the Buyer and Seller.
- The seller will be paid when confirmation of payment from the buyer is received.
- In the event of Buyer's default, the Seller will pursue the Buyer for any recourse arising from said default. The Greater Quad City Auto Auction is released from all legal liabilities.
- The Seller understands the Seller's fee will be deducted from the proceeds of sold car.

There will be a Buyer's premium of 3% (not less than \$75.00) on all purchased vehicles.

- The Buyer is responsible for any and all sales tax, license & title fees.
